**SUBJECT: REVISED 2013 UNIFORM BAIL-OUT CITING GUIDE FOR  
SUPERIORCOURT, COUNTY OF LOS ANGELES**

As part of the recent Court Consolidation Plan that was approved earlier this year, the Superior Court of California, County of Los Angeles, will close or severely reduce services in the following courthouse locations: Beverly Hills; Catalina Island; Huntington Park; Kenyon Juvenile Justice Center; Pomona North; San Pedro; West Los Angeles, the Central Arraignment Courts; and Whittier. Accordingly, the Bail-out Citing Guide has been revised to reflect these changes. The dates in the attached Revision of the Uniform Bail-out Citing Guide should be used whenever bail is posted for an appearance in the Los Angeles Superior Court. The appearance date is determined from the date of release on bail, **not the date of arrest**. The exceptions to this policy are narcotics cases filed under sections 111350(a) and 11550(a) of the Health and Safety Code. These two violations are to be cited for appearance ten days from the arrest date, at the request of the Office of the City Attorney, to avoid any taint on the case alleged because of lack of diligence in obtaining urine samples. The guide applies to all other infractions, misdemeanors and felonies.

For your convenience, we have also attached an appearance chart for some of the Los Angeles Superior Court locations to help you determine to which Department and at what time to cite the defendants to appear.
