NOTE: "#" indicates that bail amount applies to all subsections of the listed statute, or subsection. Offenses subject to P.C. Section 1270.1 are marked in this schedule with a single asterisk (*) Attached at the end of this schedule are two conversion charts related to Penal Code weapon offenses. The first table is the conversion from the old statute to the current section. The second table is the conversion from new statutes to the old. The intention of this bail schedule is to set bail based on the current statute.
